The rates listed below for a neurocognitive-neuropsychological assessment encompass the comprehensive examination, including a detailed anamnestic interview as well as the preparation and follow-up of the examination, the analysis and evaluation of the results as well as the detailed report of findings. The rates for cognitive training include the content preparation, execution and evaluation of the training as well as a review of results within a separate appointment.

The assessment and treatment of cognitive deficits and the often associated emotional-affective condition, as conducted in the COGITO center, is not displayed by the German Medical Fee Index (GOÄ). The services are therefore invoiced at the patient himself or herself, irrespective of any possible claim for reimbursement against any statutory or private health insurance company or another reimbursement agency. Please note that the details on costs refer to our services in German. An assessment and/or report in English can be associated with additional costs.

Paying by installments (four consecutive months) is possible.
